OTHER SERVICES INCLUDE CASE MANAGEMENT AND A COMPREHENSIVE NEEDS ASSESSMENT FOLLOWED BY REFERRALS TO SERVICES AND RESOURCES TO MEET THE LEGAL, FINANCIAL, PHYSICAL AND MENTAL HEALTH NEEDS OF CHILD VICTIMS AND THEIR NON-OFFENDING FAMILY MEMBERS.
