CHILD ABUSE ASSESSMENTS INCLUDE FORENSIC MEDICAL EVALUATIONS, CHILD FORENSIC INTERVIEWS, VICTIM ADVOCACY AND CRIMINAL JUSTICE SUPPORT, AS WELL AS THERAPY SERVICES AND GRAND JURY HEARINGS ONSITE.
